



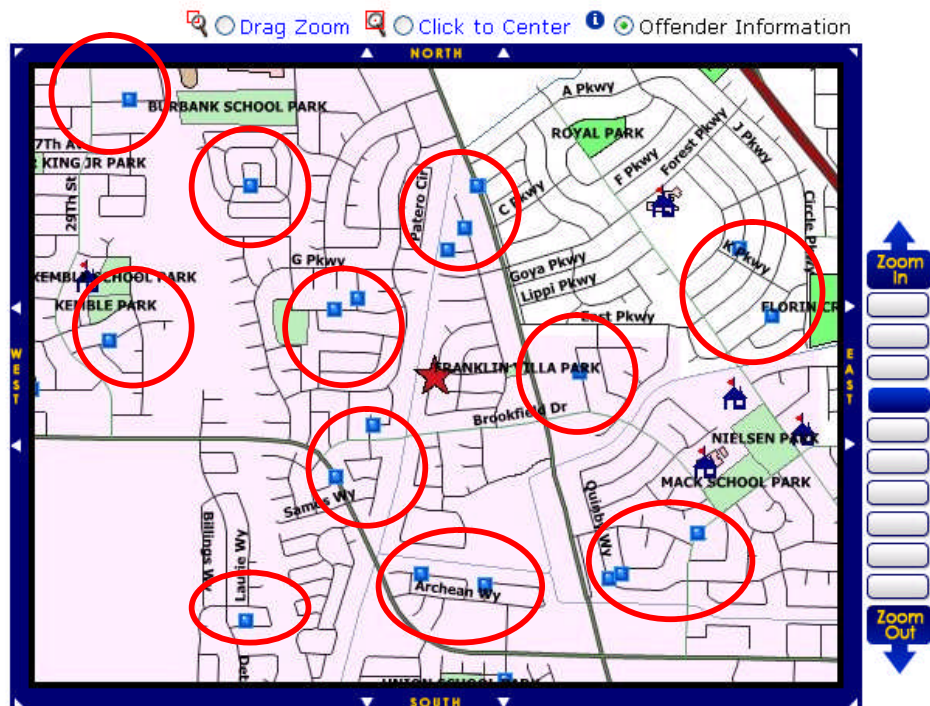

This map shows **a portion** of the number of sex offenders (circled in red) in square mile area from Weymouth Lane. This is not showing every location in the one mile area where a registered sex offender lives.

Each day I see children in Wildwood outside alone without parental oversight. I see children under 10 in groups...again...without any parental oversight. Some of these children have been observed and reported as being outside from 7:00 am to nightfall. They go from house to house and street to street.

Effective immediately, parents must accompany their children to the playgrounds available in our neighborhoods. Children can no longer play in the Wildwood streets. It is unsafe and the children are simply not monitored.

The plan for the summer is to open the pool and have other kid friendly activities such as a giant water slide, Friday night movies, talents shows, dance contests, petting zoo's and other goodies to help keep Wildwoods kids occupied. It is, however, the parent's responsibility to attend these fun events with their children.

The pool will not require a pass. The pass this year is a parent.

There will be zero tolerance for parents who do not monitor their children's safety and behavior.

WILDWOOD HOA POOL RULES:

- A. Children aged **14 and younger** must be accompanied in the pool area by a parent or other adult at all times. An adult is considered to be someone **over the age of 18**. Any children not supervised shall be made to leave the pool area.
 - B. Persons occupying the pool area must wear swimsuits or hemmed cut-off jeans. No exception.
 - C. A maximum of two non-resident guests may accompany a homeowner or tenant in the pool area unless special arrangements are made with the board of directors. All persons must have pool passes.
 - D. The gate to the pool shall remain closed and locked at all times. Any person caught admitting unauthorized persons to the pool area shall be made to leave and be subject to non-compliance assessment.
 - E. No pets are allowed in the pool area at any time.
 - F. No glassware of any kind is allowed in the pool area.
 - G. The gate shall be used for entering or leaving the pool area. Do not climb over the fence.
 - H. Radios and tape players shall be kept at a reasonable volume.
 - J. **Pool hours shall be:**
 - 11:00AM to 6:30PM
 - Wednesday, Thursday, Friday, Saturday
